With reference to the above-mentioned subject and in continuation of this office circular of even number dated 27.05.2025, it is hereby informed that the NSQ order in respect of Item No. 1551a (Name: *Amoxycillin + Clavulanate + Lactic Acid Bacillus Tablets/Capsules* – Each tablet/capsule to contain: Amoxycillin Trihydrate equivalent to Amoxycillin 500 mg, Clavulanate Potassium equivalent to Clavulanic Acid 125 mg, and Lactic Acid Bacillus – 60 Million Spores; Brand Name: Augpen LB 625) under RC-157 (Batch No. ZO5AF24052), which was earlier declared "Not of Standard Quality (NSQ)" upon testing, **is hereby revoked with immediate effect**
